Universe Description: The universe for the 2007 Survey of Business Owners (SBO) includes all U.S. firms operating during 2007 with receipts of \$1,000 or more which are classified in the North American Industry Classification System (NAICS) sectors 11 through 99, except for NAICS 111, 112, 481111, 482, 491, 525, 813, 814, and 92 which are not covered. Firms with more than one domestic establishment are counted in each geographic area and industry in which they operate, but only once in the U.S. total.
